Application has been made to the London Stock Exchange for the 4,804 new Ordinary Shares to be admitted to trading on AIM ("Admission") and it is expected that Admission will become effective and trading will commence at 8.00 a.m. on 22 November 2019.

After Admission, the total number of Ordinary Shares in issue will be 223,592,708 and the total number of voting rights will therefore be 223,592,708. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the share capital of the Company under the FCA's Disclosure and Transparency Rules.
